Accordingly, the undersigned grants the Council a nonexclusive, royalty free, perpetual license to display the Work on the Site, including any quotes or other statements made by the undersigned or others in connection with the Work or the Site generally, as well as in any other media created or published by or for the Council or the Town of Ridgefield including, without limitation, print, audio, visual, magnetic, electronic, internet or otherwise. This license may be revoked by the undersigned only by giving the Council written notice to that effect at the above address. Upon receipt of that notice, the Council will remove the Work from the Site within a reasonable time thereafter.

The Council reserves the right to select each piece of Work to be displayed on the Site, and the receipt of this Release by the Council does not entitle the undersigned to have the Work, or any other work, displayed on the Site. Further, if the Council selects the Work for display on the Site, the location, size and general appearance of the Work on the Site, as well as any other material displayed in connection with the Work on the Site, is at the Council’s sole discretion.

The Council does not charge a fee to include works on the Site, nor is there any payment to the undersigned as a result of inclusion of the Work on the Site. The undersigned agrees that the Council may also use the personal information identified below for inclusion on the Site.

The undersigned warrants and represents that he or she is the sole legal owner of, or has obtained from any applicable third parties the unrestricted right to use, all copyrights, trademarks, trade secrets, rights of publicity and other intellectual property rights in or to, or embodied in, the Work, and has the authority to grant the license and other rights contemplated above.

The undersigned also warrants and represents that the display of the Work on the Site will not infringe or violate the intellectual property or other rights of any third party. The undersigned shall indemnify, defend and hold the Council, the Town of Ridgefield, its boards and commissions, and their respective officers and employees, harmless from and against any claims, losses, damages, awards, or other liability including, without limitation, reasonable attorney’s fees, which arise from any claim by any third party of an alleged infringement of intellectual property or other rights as the result of display of the Work on the Site.

The undersigned also understands that the display or non-display of the Work on the Site is at the sole discretion of the Council, and any or all of the Work may be removed from the Site at the sole discretion of the Council at any time, and for any reason, or no reason.

This Release will bind the undersigned, his, her or its heirs, legal representatives, successors and assigns, and inure to the benefit of the Council, the Town of Ridgefield, its boards and commissions, and their respective officers and employees.
